GREENTREE COUNTRY CLUB POOL AND BEACH REGULATIONS

Swimming in areas provided is permitted only during hours described. No one shall enter the Pools or Beach unless a club lifeguard is on duty. Running, jumping, or "horseplay is not permitted on or around any of the pools or any of the pool terraces. Restrictions are set by lifeguards on duty and must be observed by everyone.

The Pool Director / Lifeguards may expel any person from the Pool, Pool area or Beach who, in his/her opinion, is acting in a disorderly manner. Floatation boats or any obstructive floats or floating chairs are not permitted in the pool. Personal umbrellas or chairs on pool decks are NOT permitted. The pool Director may make rules for use of the Pool and Pool areas and Beach which pertains to safety, health and cleanliness. All members and guests must abide by these rules.

Smoking is not permitted in the Pool area / Kiddy Pool.

Glass bottles are not permitted in Pool area / Kiddy Pool.

No persons with a fever, cough, cold, inflammation of the eyes, or any skin disease will be allowed to enter the Pools.

Lifeguards have strict guidelines and they must enforce them.

Lifeguards will give two warnings if someone is not behaving in the manners above, than you will be asked to leave the pool for the one hour.

All members please refrain from talking to lifeguard while they are on the Lifeguard chair.

No one is allowed on Lifeguard chair except lifeguards.

Diapers are not permitted in the Big Pool.

Strollers around the Pools must have their wheels locked and must be against the fence.

Food is allowed only in designated areas-tables outside of the pool area.

GREENTREE CLUB SUMMER SEASON GUIDELINES

Guests must pay the guest fee (Adult \$30, Child under 12 years of age \$15) before they enter pool area or the snack bar- that will be obtained at the office second floor through the main entrance. Lower parking lot is for members only with a valid car pass.

Food cards can only be used for food, beverages, parties; any balance that has not been used at the end of the season will not be carried over next season or refunded.

All cars will be checked for ID's, if they are not visible at the time, you will be asked to leave and park somewhere else. Every person entering the club should have **Club ID** or guest pass (if they are guests) and it should be visible at the check in gate **every day**. Without that no one will be allowed to enter the club.

You must have your food cards with you to be able to purchase food at the snack bar.

Only food cards are accepted at the snack bar.

A guest can purchase a food card for the day at the main office.

You can reload your food card at the office with increments of **\$ 50.00 – CHECK OR CASH ONLY**

Any lost food cards will be replaced for the fee of \$ 10.00 and the amount that was left on there will be forwarded on to the new card.

All members and guests coming to the office must have shoes, shirts - please Bathing suits are not allowed.

At the end of season food cards cannot be used for take home food from the snack bar or kitchen.

All kids must be supervised by an adult.

Food and beverages and alcohol are not too brought in to the club.

No refrigerators, cooking or other electrical appliances are allowed in the cabanas.

Bicycles, scooters, rollerblades, skateboards wagons or kiddy cards are not permitted on club grounds.

Dogs or other animals are not permitted on club grounds.

No pool deck chairs, tables or loungers are to be moved around – they stay in designated spots at all times.

Shoes must be worn in the snack bar area.

Club closes 15 min after pools are shut down for the evening
